CONTINUATION ORDER

29 NOV 2022

WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **Pt. Vashudev Tiwari College of Education, 107, Purani Najhai Gulab Chand Seth Ki Haweli Ke Pass, Jhansi, Uttar Pradesh-284004** for conducting B.Ed. course of one year duration with an annual intake of 100 (One Hundred only) under clause 7(12) of NCTE Regulation dated 13/01/2006 vide Order No. F.NRC/NCTE/F-7/UP-2483/2008/40067-40073 dated 29/02/2008.

2. AND WHEREAS, the recognition was withdrawn to the institution for B.Ed. course for an intake of 100 seats from the end of the academic session next following the date of order of withdrawal vide order No. NRC/NCTE/UP2483/322nd (Virtual) meeting /2020/213056-61 dated 08/02/2021.

3. AND WHEREAS, the institution filed an appeal in the NCTE Hqrs New Delhi against the NRC order dated 08/02/2021. The appeal committee passed an order dated 19/08/2021 confirming the impugned order of withdrawal dated 08/02/2021.

4. AND WHEREAS, the institution has filed W.P. (C) 12465/2022 & CMAPPL 39224/2021 in the High Court of Delhi. The Hon'ble High Court passed order dated 10/05/2022 with the following directions "*The writ petition is accordingly allowed by quashing the orders dated 8/2/2021 and 19/08/2021. It is however, made clear that this order will not come in the way of the respondent No. 2 initiating any fresh or further action against the petitioner in accordance with law. The respondent No. 2 is directed to take all consequential action including issuance of the notice on its web portal that the impugned withdrawal order against the petitioner has been quashed and the petitioner continues to be a recognized institution. The information will also be furnished to the affiliating University as well as all other relevant statutory authorities*".

5. AND WHEREAS, the matter was considered by NRC in its 379th meeting (Virtual) held on 30th September, 2022 and the committee decided to reflect the name of the institution on the official website as a recognized institution for the academic session 2022-2023 for B.Ed. course with an annual intake of 100 students. In addition, a show cause notice under section 17(1) of the NCTE Act, 1993 be issued to the institution. Accordingly, letters dated 12/10/2022 was issued to the institution.

6. AND WHEREAS, the institution has submitted reply of SCN on 10/11/2022. The matter was considered in NRC in its 385th meeting held on 17th November 2022, the NRC decided that a final show notice be issued to the institution.

7. **AND WHEREAS**, in response to the aforesaid Show Cause Notice, the reply of the institution has been received on 22/11/2022. The NRC considered the reply of the institution and decided that recognition of the institution for B.Ed. programme of two years duration with an annual intake of two units of 50 students each be continued.

8. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Pt. Vashudev Tiwari College of Education, 107, Purani Najhai Gulab Chand Seth Ki Haweli Ke Pass, Jhansi, Uttar Pradesh-284004** for continuation of recognition for **B.Ed.** Programme for two-years duration with an annual intake of **(two basic units) of 50 students each** subject to fulfilment of the following conditions:-

- (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

10. The institution shall submit to the Regional Committee as Self - Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- (a) Sanctioned programme(s) along with annual intake in the institution.
- (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last, quarter:
- (d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- (e) Fee charged from students;
- (f) Available infrastructural facilities;

- (g) Facilities added during the last quarter;
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

13. The institution shall make available the list of students admitted on its official website.

14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
